Release of Liability and Assumption of Risk

In consideration of being permitted to use the Santa Cruz Gardens Community Association swimming pool and facilities, the undersigned acknowledges and agrees to the following:

1. Participants will abide by all policies and procedures regarding swimming pool activities.
2. Risks and dangers exist during swimming activities. These risks include physical injuries, psychological injuries and even the possibility of loss of life.
3. NO LIFEGUARD IS ON DUTY. Each person is responsible for his/her actions and those of his/her children in the swimming pool and around the pool area and agrees to abide by all posted rules, policies and procedures in order to maintain the utmost level of safety.
4. I hereby assume all of the risks of participating in the swimming pool activities and will hold the owner/operator and its employees, agents, officers, trustees and affiliates harmless from any and all liability, actions, demands, damages, expenses, costs, claims and causes of action of any possible nature in respect of injury, death, loss, or damage to myself, child or property however caused as a result of or in any way relating to my activities in the swimming pool and around the pool area.
5. I further agree to indemnify and hold harmless the owner/operator, its employees, agents, officers, trustees and affiliates from and against any and all liability incurred as a result of or in any manner related to my participation in swimming pool activities.
6. If, despite the signing of this waiver, a lawsuit is brought against the owner/operator, its employees, agents, officers, trustees or affiliates in relation to participation in the swimming pool activities, I agree to pay for any and all court costs and attorneys fees incurred as a result of such litigation.
7. I also declare that neither I nor my children or my guests to the pool, if applicable, are under the influence of any chemical substance, including alcohol, at the time of the signing of this release or while participating in pool activities.
8. I agree that if any provision of this release is found to be unenforceable or invalid in any way, the remaining provisions will remain in force and effect.
9. I fully understand that swimming pool activities involve a certain level of risk of injury. My participation in these activities and my signing of this waiver are completely voluntary.

Pool Rules and Regulations

YOUR RESPONSIBILITY AS A MEMBER

All members are responsible for enforcement of proper conduct and safety. As a member, you are responsible for your family and guests at the pool. If you see a dangerous situation or a person seemingly unaware of the pool rules, it is your responsibility to also speak up. We are all neighbors. Please treat each other with respect and kindness. Please address any situation by communicating your concerns to the adult involved. If the situation escalates, if the problem continues to arise, or if you witness what you feel is a serious infraction, please contact one of the board members.

THE RESPONSIBILITY OF THE BOARD

1. In the event that a violation is reported to the board, a board member will discuss the situation with the parties involved and will try to come to a satisfying conclusion.
2. Upon a **second confirmed violation** of any regulation, there will be a letter issued to the responsible member stating the violation and enclosing a copy of these regulations as reinforcement along with a **\$50 fine**.
3. If there are more than **three confirmed violations** of any regulation by a member, there will be a letter issued to the responsible member stating the violation with a **fine of \$100**. The board of directors will place an item for consideration on the agenda for the next general meeting of the membership as to whether or not the offending member shall retain pool privileges for the remainder of the season.

Pool Rules and Regulations

Use of the pool is open to all members of the Santa Cruz Gardens Community Association and their guests. 2025 dues are \$375.00 payable to *Santa Cruz Gardens Community Association*. The 2025 pool season: April 27 – October 26. The pool will be open during daylight hours only.

OTHER FEES:

- \$100 key replacement
- \$100 cleaning fee for members who opt out or fail to complete cleaning duties

General Pool Rules

1. Members and their guests shall use the pool grounds at their own risk.
2. Members are limited to 2 guests per visit.
3. A member must accompany their guests to the pool.
4. No children under 16 are permitted on the pool grounds unless accompanied by an SCGP adult member who shall take full responsibility for them.
5. The pool safety rope that extends across the pool is there for the safety of non-swimming persons.
6. REMOVING, JUMPING, STANDING OR CLIMBING ON THE ROPE IS STRICTLY PROHIBITED.
7. Members will be held responsible for any damages caused by themselves or their guests.
8. Do not overcrowd the pool. Per state law, the maximum pool capacity is 30 people.
9. Persons with infectious skin conditions shall not use the pool
10. Members must remove their own litter and belongings when leaving the pool.
11. No pets are permitted within the gates of the pool grounds.
12. No glassware, sharp objects, or breakable items are permitted on the pool grounds.
13. Non-toilet trained children must wear a swim diaper at all times. If your child defecates in the pool, you MUST immediately alert all swimmers to exit the pool and contact a volunteer maintenance/crewman. The pool will remain closed for swimming until cleared by a board member.
14. NO RUNNING.
15. No dunking, hitting or other forms of rough play.
16. NO DIVING or FLIPS.
17. Games and swimming laps are permitted when they do not interfere with others using the pool.
18. No flotation devices larger than 38 inches (a standard inner tube) are to be used while the pool is being shared by others. No boogie boards, noodles or foam toys are permitted.
19. Anyone entering or leaving the pool enclosure is responsible for closing the gate. Do not prop the gate open for convenience purposes.
20. No member shall climb on or over the fence, fountain, or surrounding pool structures.
21. Do not tape or otherwise tamper with bathroom door locks to prevent them from locking.
22. Members arriving at the pool without a key not recognized as club members will not be admitted.
23. NO SMOKING.
24. NO ALCOHOL (See Release of Liability and Assumption of Risk document)
25. No loud music.
26. Please keep sand and dirt out of the pool. Sand and dirt damage the filtration system. Please shower off prior to entering the pool.
27. Nudity is prohibited.
28. Any person caught destroying or defacing pool property will be expelled for the remainder of the season.
29. No paid swimming lessons. Insurance policy prohibits them.
30. Home daycare providers are not allowed to bring their daycare children to the pool.
31. Adult only swim times will be at 10am and noon for a duration of 15 minutes (only upon request).

We will be monitoring the checklist to ensure duties are completed daily – please use it. If we see that you are not participating, we will be assessing the \$100 “failed to comply” fee that you signed on your Registration Form. We appreciate your efforts and thank you for your service.

Clean Up List

- ☐ Replace liners in bathroom garbage cans & pack out trash
- ☐ Remove trash from pool deck if members have forgotten to do so
- ☐ Clean Bathrooms – mirrors, sinks, toilets
- ☐ Replace TP if needed & verify there is more in the cabinets
- ☐ Wipe down tables
- ☐ Pick up random toys/clothing left behind – place in white basket
- ☐ Clean refrigerator – toss old food, wipe down inside, etc.
- ☐ Tidy up chairs – straighten, wipe down, etc.
- ☐ Sweep deck if needed
